Exercise Date

August 15, 2018

Scope

This exercise is a Full Scale Exercise, planned for approximately six hours in Gorham, NH, and upon the waters of the Moose River. Exercise play is limited to the Moose River and the adjacent shoreline in the vicinity of the River access road behind Irving Gas Station at 350 Main St, Gorham, NH.

Objective 1: Demonstrate the ability to deploy oil spill equipment utilizing common Geographic Response Plan (GRP) tactics.

Objective 2: Demonstrate the ability to assemble a spill response organization utilizing Incident Command System (ICS) principles through development and execution of an Incident Briefing (ICS 201) and implementation of on-site incident management and tactical operations.

Objective 3: Demonstrate the ability to effectively communicate between multiple local, state, and federal agencies including fire departments, police departments, and other state and federal first responders.

Threat or Hazard

Discharge of oil into a navigable waterway

Scenario

An oil spill has occurred in a section of the Portland Pipeline along Route 2 in Randolph and made its way into the Moose River. Gorham, NH has been designated as the best location to respond to the spill. Responders will utilize GRP MO-01 to deploy boom to protect sensitive resources in the vicinity of Gorham, NH and other areas downriver.
